RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted, at the undersigned's specific request, to participate in activity(s) on the following described real property and waters in Florida, to wit:

Love Our Lakes Event staging from Lake Hiawatha Preserve including cleanup activities on Lake Minnehaha, Lake Hiawatha, Lake Minneola, and Lake Susan, (identify event, waters and property).

THE UNDERSIGNED, for himself/herself, his/her heirs, family members, executors, administrators and personal representatives (all of which are included in any reference hereinafter to the UNDERSIGNED), HEREBY COVENANTS NOT TO SUE, AND RELEASES, WAIVES, AND DISCHARGES Lake County Board of County Commissioners, City of Clermont, and Lake County Water Authority officers, employees, agents, representatives, successors and assigns (herein referred to as "Releasees") from all liabilities, claims, actions, damages, costs and expenses which the undersigned, his/her heirs, family members, executors, administrators and personal representatives may have against any of the Releasees arising out of or in any way connected to the undersigned's participation in the activity(s) on the property and/or waters for bodily injury, death or property damage suffered by the undersigned before, during or after said activity or activities. The undersigned understands that this release and waiver includes, but is not limited to, any claim or action based on the negligence, gross negligence, action or inaction of any Releasee or otherwise, and is not limited to one or a single activity, but applies to all activities of the undersigned on the property, as well as in, over and under the water, springs or sinkholes.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE while engaged in or as a result of the activity.

THE UNDERSIGNED understands that the property has not been developed or maintained in any fashion to render the property usable for any activity; and has been left in its natural state with no improvements provided by the Releasees.

THE UNDERSIGNED shall defend, hold harmless and indemnify the Releasees from and against all liability, loss, claims, damages, costs, attorneys' fees and expenses of whatever kind or nature which the Releasees may sustain, suffer, or incur, or be required to pay by reason of permitting the undersigned to undertake or participate in said activities in said place.

THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Florida or other State where a claim or action may be instituted and that if any portion thereof is held invalid, it is agreed that the balance shall, not withstanding, continue in full legal force and effect.

Unless I opt-out by checking and initialing below, I, as a parent or legal guardian of a minor, hereby give Lake County, City of Clermont and Lake County Water Authority permission to film, or photograph said minor; to be used in the newspaper, agency websites or other media for the purpose of promoting Love Our Lake events and programs. I release Lake County, City of Clermont and Lake County Water Authority from any and all liability that may arise from the use of said media in this manner.
